



## John C. Snider Scholarship 2009 - 2010 Application

The Division of Continuing Education is pleased to announce that the John C. Snider Scholarship is available for the 2009-2010 academic year. Dr. John C. Snider was the Director of Continuing Education at Colorado State University from 1975 to 1986 and Vice Chancellor of the Colorado State University System (Fort Lewis College, the University of Southern Colorado, and Colorado State University) from 1986 to 1990. Upon leaving Colorado State, Dr. Snider established a fund for scholarships to be awarded to qualified nontraditional students who have the desire to “return to learning.” The first scholarship was awarded in November 1994.

To be eligible for the John C. Snider Scholarship Program, students must meet the following criteria:

- be 25 years old or older at the time of application or have a nontraditional student life circumstance (single parent, etc.)
- be enrolled in Continuing Education for a minimum of three (3) academic credits (including distance education) during the 2009-2010 academic year
- not admitted to the University for the 2009-2010 academic year
- not yet obtained a bachelor’s degree

Applications will be given preference if postmarked by October 2, 2009. The recipient will be notified in writing by November 1, 2009. The award is to be used exclusively for Continuing Education credit courses. The scholarship in the amount of approximately \$440 or less will be awarded in November 2009.
